# Vacancy for Consultant Position

Applications are invited for **one** position of Consultant on temporary basis in the project "High-Level Advocacy Initiatives for Inclusion of Children in Public Finance (Central Finance, State Finance Commissions, and State Budget and Policy Implementation"

**Purpose of Activity/Assignment:** To provide technical and advisory support to the State Finance Commission of Uttar Pradesh, with a specific focus on ensuring equitable allocation of resources for child development, poverty alleviation and promoting fiscal autonomy of local governments, and supporting the achievement of Sustainable Development Goals (SDGs).

**Scope of Work:** Recognizing the need for accelerated rate of progress to achieve SDGs, the state of Uttar Pradesh; has initiated many efforts and been open to system strengthening and monitoring to support high impact interventions. In this context, UNICEF as a lead and technical partner of GIDS has identified areas of intervention to engage in high level advocacy pertaining to public finance.

The consultant will play a pivotal role in strengthening fiscal management, promoting equitable resource allocation, and advancing sustainable development in the State by engaging in the following major tasks:

# 1. State Finance Analysis and Equitable Devolution

- Conduct a comprehensive time-series analysis of Uttar Pradesh's finances, focusing on revenue and expenditure trends, debt sustainability, and fiscal performance.
- Assess the state's fiscal space and identify opportunities to expand allocations for priority sectors, including women and children's programs.
- Develop or refine an equitable devolution formula for allocating resources to local governments, considering factors such as population, poverty, and development indicators.
- Analyze relevant data on socio-economic indicators to inform policy decisions and support evidence-based policymaking.
- Provide technical support for disaggregating data at the Gram Panchayat level to aid SFC data requirements.
- Develop policy recommendations to strengthen the SFC's role in promoting equitable resource allocation and addressing regional disparities.

### 2. Climate Finance and Sustainable Development

- Assess Uttar Pradesh's climate finance needs and identify potential funding sources.
- Develop a framework for climate-resilient budgeting and expenditure planning.
- Establish a system to track climate finance flows and expenditures.
- Propose policy recommendations to mobilize and effectively utilize climate finance for sustainable development, particularly in the agricultural sector.
- Support the integration of green budgeting principles into the state's financial planning process.

# 3. Child Budgeting and Social Development

- Develop a methodological framework for introducing a Child Budget Statement (CBS) in Uttar Pradesh.
- Analyze department-wise allocations for child-related programs (health, education,

- protection).
- Identify and categorize spending specific to these programs.
- Assess the effectiveness of current allocations in meeting children's needs.
- Develop a Child Budget Statement for the state of Uttar Pradesh (2025-26) with recommendations for better alignment with developmental objectives.
- Support the implementation of outcome-based budgeting (OBB) principles to enhance the efficiency and effectiveness of public spending.

#### **Key Responsibilities:**

#### 1. Understanding the Mandate of Finance Commissions:

- Develop a deep understanding of the roles and responsibilities of the Central Finance Commission and the State Finance Commission.
- Analyze the impact of these commissions' recommendations on the state's fiscal health, particularly in relation to child development and poverty alleviation.

#### 2. Data Analysis and Research:

- Collect and analyze relevant data on child poverty, demographic trends, and economic indicators.
- Conduct research on best practices in fiscal federalism and resource allocation for child development.
- Identify data gaps and recommend strategies to improve data collection and analysis.

## 3. Policy Analysis and Recommendations:

- Analyze the implications of proposed policies and budgetary allocations for child development and poverty reduction.
- Develop policy recommendations to ensure equitable resource allocation for child-focused programs and services.
